III. PROJECT OVERVIEW

- a. As described in Section 01010 SUMMARY OF WORK – The work to be performed under this Contract shall consist of furnishing all labor, materials, tools, equipment and incidentals and performing all operations in connection with the cleaning and cement lining of various water mains in accordance with the Specifications and subject to the terms and conditions of the Contract including all necessary appurtenances.
- b. The Project will be awarded in one Contract. Fifty-one percent (51%) of the Work under the Contract Documents must be self-performed by the General Contractor. The Project will be awarded by base bid on a lump sum basis for the performance and completion of all Work required by the Contract Documents.
- c. Contractor shall be required to furnish a Performance Bond and Payment Bond, satisfactory to the Owner, each in the amount of 100% of the Contract Price.
- d. It is the desire of the Owner that local businesses, including minorities and disadvantaged subcontractors, are given the opportunity to participate on the various parts of the Work.

- e. As described in Section 00100 SUMMARY OF WORK - Bid Submittal Requirements
- The Bid;
 - The Bid Bond;
 - Statement of Bidder's Qualifications;
 - Statement of Equipment;
 - Corporate Certificate, if the Bidder is a corporation;
 - Statement of Minority-Owned Firm Utilization;
 - Contractor's License Certification;
 - Photocopy of State of Georgia Utility Contractor's License;
 - Photocopy of Certificate of Authority from Georgia Secretary of State's Office to do work in Georgia (if out of state contractor); and,
 - Non-Collusion Affidavit of Prime Bidder
- f. The Owner reserves the right to reject any or all Bids. The Owner reserves the right to waive informalities and technicalities.
- g. The equipment and materials to be furnished will be installed at the locations shown on Maps. Prior to submission of bids, the bidders are encouraged to visit the work sites and acquaint themselves with all the requirements of these specifications and all local conditions that may affect the work

IV. CONTRACT DOCUMENT CLARIFICATIONS

1. See Section 010101 SUMMARY OF WORK for the details of all the requirements of this project.
2. There is a typo in Section 01010-2, Part 1.4 Scope of Work letter F. This should read, “**All material for the cement mortar with the exception of water will be furnished by the Contractor.**” Addendum 1 will address this issue.
3. There is a typo in Section 01010-2, Part 1.4 Scope of Work letter G. This should read, “**All equipment for applying the cement mortar lining will be by the responsibility of the contractor**”. Addendum 1 will address this issue.
4. There is a typo in Section 01010-2, Part 1.4 Scope of Work letter J. Need to replace “**building**” with **buildings**. Addendum 1 will address this issue.
5. See Article 4 in Section 0700 General Conditions for Insurance requirements.
6. Construction sequencing/coordination is Contractor's responsibility.
7. When work is being carried out on public and/or private property, right-of-ways and/or easements, the contractor is responsible for obtaining all permits, permission and approvals required from either entity to do work on their property, right-of-ways and/or easements. Agreements must be obtained between the Contractor and all public and private property owners, including but not limited to **Macon-Bibb County** for access to sewer easement and storage of equipment if required.
8. Erosion Control is Contractor's responsibility.
9. Time weather delays are outlined in General Conditions.

10. Pre and Post Construction video/photographs are Contractor's responsibility.
11. Contractor must be on official Bid List in order to submit a bid. This means you must purchase Bid Documents from MWA. Official Bid List is used to distribute any Addenda.
12. Any disturbance must be restored to "as good or better" than prior to disturbance being made.
13. MWA does not expect change orders from General Contractor.
14. Pre-Bid Meeting sign-in sheet and any Addenda will be posted on MWA website.
15. Any out of state contractors will be required to complete Section 00430 Contractor's Certification of Authority and, if awarded the contract, be required to provide a Georgia Revenue Bond.
16. Bid Item No. 4 "Allowances" will be used at the direction of the Engineer.
17. Bid Item No. 5a. "Soils and Concrete Testing" is for additional testing needed other than slump test for the lining as stated in Specification 01010-7, Part 2.1 Pipe Cleaning and Lining Operations Scope of Work letter Q.
