MWA customers enjoy flexible outdoor watering

But changes in 2011 rates and methodology will impact heavy water users

As a result of the Georgia Water Stewardship Act, which went into effect last summer, Macon Water Authority (MWA) customers are enjoying a more flexible and relaxed outdoor watering schedule.

Currently, MWA customers may water their landscapes daily from 4:00 p.m. to 10:00 a.m. the next morning.

Daily outdoor watering of landscapes is defined as watering for the purposes of planting, growing, managing, or maintaining ground cover, trees, shrubs, or other plants.

Outdoor water use for any purposes other than for watering landscapes must adhere to an odd-even system.

The MWA encourages its customers to be careful not to overwater, but water wisely and only when landscapes need it. Some helpful outdoor watering tips:

- Water during the early morning hours, when the air is coolest and winds are calmest.
- Water deeply to encourage root growth, without soaking landscapes below the root zone, which is unnecessary and wasteful. (Note: if you can grab a handful of soil an inch deep and squeeze water out of it, then it is overwatered.)
- Aim sprinklers at the lawn, rather than at streets or side-walks, and avoid watering to the point when water runs off the landscape.

- Take advantage of rain events and cease watering during these times.
- Water problem areas or hard to reach places by hand.

The MWA reminds customers that this year's water/sewer bills will be impacted by slight increases in consumption charges, but more noticeably by the new methodology used to calculate sewer bills.

Previously, the MWA determined sewer rates according to a fixed monthly average of sewer use from the eight lowest months during the past year. This year, MWA sewer rates are based on 80% of that current month's water consumption. Thus, as outdoor watering

increases, so too does a customer's water AND sewer bill.

The MWA also reminds its customers that water/sewer consumption charges, in addition to the methodology for calculating monthly sewer bills, changed in January of 2011. This year, the MWA has increased its water volume/consumption charges by 10 cents per hundred cubic feet (CCF) and its sewer volume/consumption charges by 15 cents per CCF.

Young anglers age 16 and under are invited to take part in the Macon Water Authority's (MWA) annual Kids Fishing Derby, to be held Saturday June 4, at Javors Lucas Lake. Academy Sports & Outdoors once again will be serving as the premier sponsor of the event. The Derby registration opens at 7:30 a.m., with the weigh-in for the competition beginning at 11:00 a.m.

The annual Kids Fishing Derby is held each year on one of the days that the Georgia Department of Natural Resources (DNR) designates as a free fishing day, when anglers can fish Georgia waters without a permit. The state agency offers these permit-free days a few times each season to encourage citizen enjoyment of the outdoors and the sport of fishing.

The Kids Fishing Derby will offer a friendly competition between participants in four age group categories (3-5, 6-9, 10-13, and 14-16) who will be vying for first, second, and third place prizes for the biggest catch in their division. The contest also will award the "biggest



catch of the day" that will be given to the Derby's overall winner.

Participants must be accompanied by a parent or attending adult, who may also fish in designated areas for free during the day. However, children participating in the Derby must catch their own fish to enter into the competition.

The two primary ponds where the Derby will be held will be stocked with a variety of fish, as Javors Lucas Lake is noted for a healthy population of bass, bream, and catfish. Attendees must bring their own fishing poles, bait and tackle. Guests should

access Lucas Lake via Broach Lane off of Upper River Road.

The MWA and the many event sponsors in addition to Academy Sports will be providing giveaways and prizes for those attending, in addition to the gifts for the winning participants in the Derby. Lunch and refreshments also will be provided, and admission is free.

Melissa Thorpe has retired after 17 years of service as the Authority's Chief Financial Officer. Ms. Thorpe came to the Authority at the time of one of Macon's greatest natural disasters – the 1994 flood. Her work was instrumental in the Authority successfully receiving all of the financial aid it was due from federal and state government agencies, as a result of the flood, notes MWA Chairman Frank Amerson, who was at the forefront of those efforts as well. Stan Shear recently retired as an Assistant Maintenance Manager at the MWA, following 21 years of service. Shear was commended for his skills as a craftsman, who helped solve countless problems in maintenance and operations for the Authority, with a positive attitude and willingness to mentor fellow employees with less experience.

Finally, Mack Jones has retired after 12 years as the Manager of Macon Soils, which is a subsidiary of the MWA that handles the environmentally sensitive recycling and reuse of biosolids.

Detours in place around MWA Headquarters

Due to a construction project on storm water infrastructure downtown, Second Street will be closed from Pine Street to Hemlock, and possibly even down further to Oglethorpe Street, until further notice. Customers driving to the MWA Albert Billingslea Headquarters on Second Street will have to follow detours to get to the building.

Those coming to the MWA Headquarters on Second Street (from Riverside or I-75/I-16 from the east) will want to take Pine Street to Third Street (south), turn RIGHT on Third Street, then RIGHT on Oak/Hemlock.

Those coming from the south on Hwy. 247/Broadway should follow it until it becomes MLK, then take a LEFT onto Oak Street, which becomes Hemlock at the next block.

Those coming from Mercer University or I-75 South should proceed south on Oglethorpe, turn LEFT onto Third Street and then LEFT three blocks down (past Arch and Hemlock St. Lane) on Hemlock Street.
