Current Fees for establishing New Customer Accounts

These Fees may be updated from time to time.

Application Fee: \$25.00

Same Day Service Fee: \$35.00

Meter Fee to replace a stolen or abandoned 5/8" Residential Meter: \$75.00

Meter Fee to replace a stolen or abandoned 1" Residential Meter: \$120.00

Deposits and documentation necessary for new customers to establish services are determined based on the credit score of the applicant and the payment history for the service location of the account.

Service/Billing Initiated

Service will begin at the time meter is installed or when a reading is first taken, approximately 30 days after meter installation for a new account. Monthly base rates will apply even without volumetric consumption.

Sewer service for single family residential and owner occupied, master metered residential customers, with only a residential water account, will have monthly sewer charges calculated and billed based on 80% of the water usage registered on their residential water meter. Sewer consumption charges for customers without a separate irrigation meter will be capped at 30 CCF.

Sewer service for single family residential and owner occupied, master metered residential customers, with a residential account and an irrigation account, will have monthly sewer charges calculated and billed based on 95% of the water usage measured on their residential water meter. There is no cap on sewer service charges for customers with separate irrigation meters.
