**CAUSE OF MINOR SPILL:** After the blockage was removed, it was determined that the cause of this spill was grease. There are no commercial sources of grease upstream from this location and residential grease is not regulated.

**ESTIMATED VOLUME DISCHARGED:** 2,600 gallons

*(Please note that this quantity is only a calculated **estimation** of the volume of sewage that spilled from our system. More sewage may have escaped the system.)*

**RECEIVING WATERS:** Ditch feeding Wolf Creek

**SERVICE BASIN AFFECTED:** Wolf Creek

**WRF SERVICE AREA NPDES PERMIT:** GA0024546

**CORRECTIVE ACTION TAKEN TO MITIGATE OR TO REDUCE ADVERSE EFFECTS:**

The blockage has been cleared and debris has been removed. This area has also been sprayed with an enzyme treatment for organic waste called Bio-Bug.

**SPILL STATUS:** The blockage has been removed; sewage is no longer escaping.

**SIGNS POSTED:** Tuesday, May 2, 2023

**CORRECTIVE ACTION TAKEN TO PREVENT FUTURE SPILL:** The details of this overflow have been forwarded to our Grease Management team for further investigation. The line is scheduled to be cleaned with grease emulsifier and televised. It has also been added to the weekly Hot Spot Inspection list for monitoring.
