MWA Stormwater Management started in January 2021 and had a list of flash flooding areas, "Hot Spots," 54 locations. As of May 2025, the list has been reduced to 28 locations because of maintenance and repairs on the system.

MWA/MBC Clean-up Partnership

Stormwater Division has swept 41 streets/roads where MBC cleaned up illegal dumping, and swept the Central Business District, the total for May 2025 is 10.15 curbed miles (2025 Total – 157.51 CM)
