This addendum forms a part of the Contract Documents and modifies the original Specifications and Contract Documents as noted below. Acknowledge receipt of this addendum in the space provided on the Bid Form. Failure to do so may result in disqualification of the bidder.

QUESTION RECEIVED REGARDING CLARIFICATION OF BID QUANTITIES

Attached to this Addendum is a revised Bid Sheet.

- 1) **QUESTION:** What line item does the HW for the 16" DR 32.5 HDPE go under?
RESPONSE: There has been a new line item added to the bid form. Please see revised bid form attached.
- 2) **QUESTION:** What is the Engineer's budget for the project?
RESPONSE: The budget for this project is \$200,000.
- 3) **QUESTION:** When is the expected start date?
RESPONSE: Pending the approval of the successful bid by the MWA Board and the execution of the contracts, the start date could be early October. After the contracts are executed, a pre-construction meeting is scheduled and standard procedure is to allow ten days from the meeting for Notice to Proceed.
- 4) **QUESTION:** Is there any place to store the rip-rap other than the staging area?
RESPONSE: No, rip rap shall only be stored at the staging area.
- 5) **QUESTION:** Can we reuse any of the rip rap?
RESPONSE: Yes, the rip rap may be reused.
- 6) **QUESTION:** Is there an area where we can take any unsuitable fill material near the site? If so, where?
RESPONSE: Yes, contractors may use the bone yard on-site. Google Earth snip on the following page.

The Bidder agrees hereby to commence Work under this Contract, with adequate personnel and equipment, on a date to be specified in a written order of the Engineer, and to fully complete all Work under this Contract within one hundred twenty (120) consecutive calendar days from and including said date specified in the written order of the Engineer. Bidder further agrees to pay as liquidated damages, the sum of \$500.00 for each calendar day thereafter required to achieve substantial completion of all Work.

The Bidder declares an understanding that the quantities shown for unit price items are subject to either increase or decrease, and that should the quantities of any of the items of Work be increased, the Bidder proposes to do the additional Work at the unit prices stated herein; and should the quantities be decreased, the Bidder also understands that payment will be made on the basis of actual quantities at the unit price bid and will make no claim for additional costs or anticipated profits for any decrease in quantities; and that actual quantities will be determined upon completion of Work, at which time adjustment will be made to the Contract Price by direct increase or decrease.

In case of discrepancies between the figures shown in the unit prices and the totals, the unit prices shall

apply and the totals shall be corrected to agree with the unit prices. In case of discrepancies between written amounts and figures, written amounts shall take precedence over figures and the sum of all Bid extensions (of unit prices) plus lump sum items shall take precedence over the Bidder's represented BID TOTAL.

The Bidder furthermore agrees that, in the case of a failure to execute the Contract Agreement and Bonds within ten days after receipt of conformed Contract Documents for execution, the attached Bid Bond accompanying this Bid and the monies payable thereon shall be paid into the funds of the Macon Water Authority as liquidated damages for such failure.
